Any person who violates any of the provisions of these City Ordinances, for which another penalty is not specifically provided, shall be guilty of a Class B misdemeanor and shall, upon conviction thereof, be punished by a fine of not more than One Thousand Dollars (\$1,000.00) or be imprisoned for not more than thirty (30) days, or by both such fine and imprisonment, for each offense.

*All applicants will have a registered agent who is a North Dakota resident, citizen of the United States, and of good moral character. If applicant, silent or otherwise, is a partnership or co-partnership, or a private corporation, all officers, directors or stockholders of the partnership or corporation, and the person or persons who shall conduct and manage the licensed business for the corporation shall possess all of the qualifications required herein for an individual licensee, and must be personally qualified to obtain a license. If applicant is a corporation, the corporation must be duly licensed in the State of North Dakota and have a properly designated registered agent. The state of incorporation, the amount of its authorized capital stock; amount in capital stock; whether such corporation is a subsidiary of any other corporation; and if so the name, place of business, and post office of the parent company; the purpose for which such corporation, parent, and subsidiary, were incorporated, and if the corporation is authorized to do business in the State of North Dakota. The names, places of residence, and post office address of each person and/or partner having any financial interest therein or in excess of 25% of the stock or have charge or management and/or control of the establishment for which the license is requested.

As a condition to the issuance to any license, applicant shall obtain the following minimum insurance coverage and maintain it all times throughout the life of the licensee. Insurance certificates shall specifically provide that a certificate will not be modified except upon 30 days prior written notice to the City of Wahpeton, ND. Comprehensive General Liability (including

premises operations; independent contractors' protective; productors and completed operations; broad form property damage:

Bodily injury and property damage (combined limit) coverage of \$1,000,000 per occurrence and \$2,000,000 aggregate.

Personal injury coverage of \$1,000,000 per occurrence and \$2,000,000 aggregate.

Property damage liability for hazards such as explosion, collapse, and underground.

Comprehensive automobile coverage (owned, non-owned, hired) Bodily Injury and Property Damage (Combined limit) of \$1,000,000 per occurrence and \$2,000,000 aggregate.
